- c) Particulars of all Postal Ballots forms received from the Members have entered in a Register separately maintained for the purpose.
- d) Envelopes containing Postal Ballot Forms received after 5:00 P.M. 17th January, 2021, if any, were not shared to us and they were not considered for our scrutiny.
- The Company had appointed National Securities Depository Limited ("NSDL") as the agency for providing the remote e-Voting platform. (https://www.evoting.nsdl.com)
- f) The e-voting period remained open from Saturday, 19th December, 2020 (9.00 a.m.) to Sunday, 17th January, 2021 (5.00 p.m.).

g) The Shareholders holding shares either in physical form or dematerialized form as on the cut-off date i.e. Friday, 20th November, 2020 were entitled of the con-
